Bidding is open to all eligible Nepalese bidders.
- 2. The Kageshwori Manohara Municipality, Office of the Municipal Executive invites Electronic bids for S. N. 1, 2, 3, 4 & 5 works as indicated in details of work below under NCB-Single Stage Two Envelope Bidding procedures and Electronics or Sealed Bids for S. N. 6, 7, 8, 9 & 10 works from eligible bidders for the construction as indicated in details of work below under NCB-Single Stage Single Envelope Bidding procedures as in accordance with e-GP Procurement Directive 2074. After that time web site will not accept automatically any bids submitted late also late bids of hard copy will be rejected.
